

#### Introducing Member-Owned Woody, Inc.

In 1983, Woodhaven was coming into its own. Much of the major development of both Phase 1 (Sections 1 – 15) and 2 (Section 16 – 29) were completed. The Association, as has always been the case from Woodhaven's inception and remains to this day, was looking at new ways to provide enhanced amenities and services for Property Owners and guests.

"The development of Woody, Inc. (Service Center, General Store/Restaurant & Bait Shop) to provide services to the members of the Association is an important step to assure the future of Woodhaven," wrote Pat Sherrard, Editor, in the 1983 Spring-Summer edition of the Woodhaven News.



The Service Center opened on February 20, 1983 and the General Store was stocked and open in mid-April. The original General Store was in a rustic-style building just west of where the current Rec Plex Building sits.

"Turning Woodhaven into another city is not the intent of the Board of Directors nor the staff," Don Liggett, Executive Director, said in explaining the importance of these services to Property Owners. "Yes, we believe Woody, Inc. will be very successful and that all Association members will be pleased to have these services available here at Woodhaven rather than having to go off property for items needed to enjoy their weekends

at their campsites."

The General Store was a huge hit from the beginning, as reports from those early years detailed campers waiting in line outside the store on Fridays to get in and buy needed goods for their weekend at Woodhaven.

#### Camping "Essentials" from the General Store

Advertisements for the General Store began running in the Woodhaven Weekly (now the Leisure Times) in May 1983. The first General Store was truly considered a "convenience store", offering a limited selection of items and products considered necessities for camping—paper towels, hot dogs, marshmallows, charcoal, soft drinks, and instant coffee. It also had a deli tub with fresh potato salad, cole slaw, macaroni salad and shrimp salad; fresh meats for the grill and, of course, a great variety of beers for relaxing around the campfire. Beer selections included 6-packs of Pabst Blue Ribbon for \$2.29, 12-packs of (warm) Stroh's for \$4.29, and 24-packs of Old Style for \$7.60.

By 1989, the General Store outgrew its space, and a new building (currently the Rec Plex) was constructed just east of its original location, allowing the store to increase its selections, including fresh baked items, expanded

deli and ice cream window. The old General Store was converted into an arts & crafts space in one half of the building, and the restaurant was relocated to the other half.

#### The General Store Finds its Forever (or at least longterm) Home

In January 1999, a Strategic Planning Committee was formed to evaluate and generate ideas to improve the Sports Core area. The Committee devised a detailed 8-year plan with the idea of separating the recreational amenities from the commercial amenities in the Sports Core area and a redesign to offer less congestion and more parking. With these goals in mind, the current General Store Building opened in March 2004, which also housed the current restaurant, bank, laundromat and, at the time, bait shop. Several changes were made throughout the years since the building opened, including expanding the laundromat into the old bait shop area and a renovation of the restaurant.

#### The General Store Today & Upcoming Season Hours

The current General Store has come a long way since its opening in 1983. While still offering all the camping necessities, selections have been expanded to offer most items found in a full-service grocery store, including a full-service deli, fresh deli meats and salads, fresh produce, hand-dipped and soft serve ice cream, and a full-service restaurant. The restaurant, which was renovated two-seasons ago, not only offers excellent food at a reasonable price, but a relaxed and comfortable ambiance with a throw-back camping diorama, historical Woodhaven photographs and framed original section plat maps for viewing.

The General Store will open for weekends in April on Saturday, April 10, with expanded hours on Spring Fling Weekend. General Store April 2021 hours are:

Saturday, April 10: 8 a.m. – 4 p.m Sunday, April 11: 8 a.m. – 12 p.m. Saturday, April 17: 8 a.m. – 4 p.m. Sunday, April 18: 8 a.m. – 12 p.m.

#### Spring Fling Weekend

Friday, April 23: 3 p.m. – 8 p.m. Saturday, April 24: 8 a.m. – 8 p.m. Sunday, April 25: 8 a.m. – 1 p.m.

The restaurant will also open Spring Fling Weekend on Saturday and Sunday from 8 a.m. to 11 a.m. Pizza Plus will be on Saturday, from 12 p.m. to 7 p.m. Check out our website calendar or mobile app for Store, Restaurant and Pizza Plus hours beyond Spring Fling Weekend through the remainder of the season.

### ASSESSMENT REMINDER

A minimum payment of \$680 for lots with sewer and \$617.50 for lots without sewer needs to be received in the Association Office on or before March 31, 2021 to avoid additional late fee charges. Property Owners who do not meet this requirement will be assessed a late fee of \$50. Please make sure your payment is received before the March 31, 2021 due date.

The Administration Office is currently open Monday through Saturday from 8:30am to 4:30pm and closed on Sundays. Property Owners visiting Woodhaven are encouraged to stop in the office during these times. Other options include dropping your payment office in the office drop box or making your payment at the Front Gate when the office is closed. Property Owners can also call the office during business hours to authorize payment by credit card or debit card; choosing this option includes a 3% processing fee. In addition, the Association's website at www.woodhavenassociation. com and the Woodhaven App provide Owners with links to the payment portal. Payment instructions are provided in the payment portal. If you need more information about this service, please contact the Association Office at (815) 849-5209.

Property Owners who fail to make a timely payment will also have their passes deactivated until the required payments are made. The inactivation process will be run following the March 31, 2021 due date. Multiple lot owners are required to make payments on all the properties they own. If a multiple lot owner is delinquent in assessments on any of their properties, the passes on all lots owned will be deactivated until the required payments are made. Please contact the Association Office if you have questions or concerns with these policies.

The Association continues to receive an excellent response to the early payment option for the 2021-2022 assessment with a significant number of Owners paying their balances in full. If you have already paid your assessments, thank you and enjoy Woodhaven's 50-year Celebration!

#### 2021-2022 Budget

Staff has completed the final draft of the 2021-2022 annual budget figures. This information is presented in the 2021-2022 Annual Budget Report, which includes a monthly line-item budget, our five-year operating plan, our reserve plans, and other information related to our long-term budget planning. The 2021-2022 Annual Budget Report was and/or will be presented to the Board of Directors and the Finance Committee at meetings scheduled in March. The final draft of this report is included on the March 22, 2021 Board Meeting Agenda.

Specific information on the Association budget was published in the December issue of the *Woodhaven News* and is also available for viewing on the Members tab on our website at www.woodhavenassociation.com. The final figures include adjustments to both the operating and restricted portions of the budget and were based on information obtained since the Budget Hearing in November. The following adjustments were made after the November 14th Budget Hearing.

- The net change to the bottom-line projections for the operating fund has decreased the projected deficit by \$8,000 to a total projected deficit of <\$176,061>. Detailed line-item changes include:
  - » Income from pass replacements was increased by \$4,000.
  - » Office supply expense were increased by \$4,000, related to pass replacements.
  - » Projected income from Woody, Inc. was increased by \$8,000 based on reducing real estate tax expenses on a reassessment of the Service Center location.
- The net change to restricted fund projects has decreased projected expenditures by \$136,700. Detailed line-item changes include:
  - » \$30,400 was added to Computer System Upgrades at the Service Center to account for improvements to the pay-at-the-pump services of our gas pumps.
  - » \$44,000 was added to include funding for the replacement of the JCB Load All loader damaged from an equipment fire occurring in January 2021.
  - » Carry over funds of \$22,000 are added to the 2021-2022 project list to complete improvements to the Four Seasons Playground not completed in 2020-2021.
  - » Carry over funds of \$4,000 are added to the 2021-2022 project list for unacceptable material drop-off improvements not completed in 2020-2021.



» Carry over funds of \$36,300 are increased on the 2021-2022 project list for the dredging projects beginning in 2020-2021.

Carry over projects are line items approved within the 2020-2021 fiscal year budget, which will not be completed by March 31, 2021. Reserve funding has been allocated for these projects and the dollar amounts represent the portions of the budget that have not been expended. A copy of the 2021-2022 Annual Budget Report is available for owners to view at the Association. Owners can also view this report on the Association's website under the Members tab. If you have questions or need additional information on the budget, please do not hesitate to contact us at the Association Office.

#### **PROJECTS & OTHER UPDATES:**

- Dredging equipment arrived on property toward the end of February and was temporarily placed in the Nature Center / Bait Shop parking lot. This was done in advance of the road postings to make sure we could get started on this project in March. Mobilization has or will take place in March with dredging beginning later in the month. This project includes improvements to Blue Gill Lake, Pine Lake, and Hidden Lake.
- With improving weather conditions, debris clean-up from the winter ice storms has begun in earnest on our common properties. There is a lot of clean-up work to do, and it will not be limited to common properties. As attendance levels increase and Owners begin to clean-up individual properties the brush piles will be larger this year and it will take longer to get them picked up. Please be patient with this process and know we will be making every effort to address these tasks in timely manner.
- Over the winter months several projects have been approved to replace vehicle and equipment items included on the project lists for FY 2021-2022. We have also completed several improvements to facilities including some painting, décor, and flooring upgrades.
- We are in discussions with Shady Oaks Country Club on an agreement for the 2021 golf season. At this time, our objective is to continue with a program like what was applied in 2020. If approved, the Association will enter into an agreement prior to the beginning of the 2021 golf season.

#### **Delinquent Tax Property Notices**

We received a list of properties from Lee County's Delinquent Tax Agent on possible lots to be offered in the County's sealed bid sale planned for later this year. Delinquent owners have until May 20, 2021 to redeem the taxes or their properties will be offered for sale by Lee County. The current list includes 66 Woodhaven lots, with approximately 50 properties current in assessments with the Association. As a courtesy to these Owners, letters have been sent to advise them of their delinquent status with Lee County. If the tax balances are not redeemed, the property will be offered for sale through a sealed bid process later this year.

# Important Information About Tornado Sirens

Sirens are for <u>OUTDOOR</u> warning purposes and are not meant to be heard indoors.

Hearing a siren is a signal to get indoors and seek additional information.

It does NOT mean the threat has ended when the sirens stop sounding.

Sirens are activated by city or county officials, not the National Weather Service.

## **Woodhaven Weather Alert Siren Info**

Here is a quick refresher on Woodhaven's procedures for weather notifications and tips for taking shelter during inclement weather at Woodhaven.

- » Note there is NO all clear siren, you should use your own judgement for leaving sheltered areas. Our procedures are mirrored after other cities and municipalities. In fact, NO municipalities in Illinois have "All Clear" signals, as weather is unpredictable.
- » We cannot tell you what the safest option for you is personally. All comfort stations and any OPEN facilities will be available for shelter. But please keep in mind that traveling in vehicles can be just as dangerous.
- » Have a Plan! Practice your family's procedure and make sure all members know what to do in case of inclement weather.
- » Invest in a weather radio and have plenty of batteries. The most up-to-date info will be released through the NOAA weather radio and the National Weather Service.

The objective of Woodhaven's Siren procedures provides advanced warning for staff and general Woodhaven public of conditions present for the development of a tornado/funnel cloud in the immediate Woodhaven Lakes area. The sirens warn to say tuned to local weather reports and to be prepared to take cover. Please remember, these are <u>outdoor</u> warning sirens and are not meant to be heard when indoors.

The sirens are activated when:

- » Woodhaven Lakes receives a report by the NOAA weather radio, TV report, or public radio from the National Weather Service of a tornado warning that includes the following areas: Amboy, Sublette, Woodhaven Lakes, southeast or southwest parts of Lee County.
- » A phone call from the Lee County Amateur Radio Emergency Service (ARES) or Lee County Sheriff's Department that a funnel cloud or tornado is heading toward Woodhaven.

Reminder - Sirens are tested the first Tuesday of each month at 10 a.m., barring inclement weather. In inclement weather, testing is moved to the following week.

#### Taxes vs Assessments

Woodhaven is definitely a great place to get away from the grinds of daily life—work, traffic & noise. As with most hobbies and recreational activities, however, there are varying degrees of financial costs and expenses that go along with the fun and relaxation, and Woodhaven is no exception.

When you make the commitment to yourself and your family to purchase recreational property at Woodhaven, you also make the pledge to accept the accompanying financial responsibilities. Two of the primary financial obligations involved at Woodhaven are the annual Association assessments and the yearly county property taxes. There is often a misconception that the assessment and county tax bill are one in the same. It's very important to learn and know the differences between these two expenses, what they provide, and who they are paid to.

#### **ANNUAL ASSOCIATION ASSESSMENT**

When you purchase property at Woodhaven, you become a member of the Woodhaven Association. As a member of the Association, you are responsible to fund your ownership share of the Association's annual budget. This budget includes annual operating costs, such as cost to operate facilities, including the pools, water and sewer facilities and other amenities; providing programs and services; and maintenance of buildings and common grounds. Also included in the annual budget is a reserve fund, which sets aside a certain amount of cash for future improvements, emergencies or unexpected repairs and improvements.

Every year Woodhaven's Board of Directors and volunteer committees spend months reviewing past budgets and working with staff to determine current and future budgetary needs based on goals set by the Board. Through this process, the Board then determines each individual property's share based on the number of billable properties at Woodhaven and Woodhaven's overall budgetary needs. The budget process is well documented through the *Woodhaven News* and allows Property Owner input at several stages of the process. The process culminates in November of each year when the proposed budget for the upcoming fiscal year is presented to the members in an open meeting. The following fiscal year budget is typically approved by the Board of Directors at the December Board meeting. After the Board approves the budget, including the amount to be billed to each individual Property Owner, staff begins preparing the assessment bills, which are typically mailed to Property Owners in January each year, with a March 31 due date for the first installment payment.

It is important to understand that the individual annual assessment amount is based on the number of billable properties located at Woodhaven. Therefore, every billable lot with sewer service is billed the exact same assessment amount. Also, every lot without sewer service is billed the same amount as every other lot in Woodhaven without sewer service. And because the assessments are actually billed to each billable lot, Property Owners who own multiple lots are required to pay an assessment for each lot they own.

#### **PROPERTY TAXES**

If you own a home or property somewhere other than Woodhaven, then you are probably well aware of what property taxes are and how they are assessed. For all others, property tax on real estate is typically levied by local government at the municipal or county level and they help support local education, police/fire protection, local governments and other local infrastructure. The tax is usually assessed at a percentage of two components—the value of the land, and any improvements or building value.

At Woodhaven, assessed land values can vary greatly depending upon location within the property. For example, property on a lake would be assessed at a higher value than a lot not located near water. Structures and improvements at Woodhaven that can be assessed include free standing room additions, covered decks, and sheds. Park models, travel trailers, fifthwheels and other RVs cannot be assessed, as they are considered personal property.

Woodhaven properties are located in Lee County, and as such, are taxed by Lee County Treasurer's Office. With more than 1,700 acres of property, Woodhaven encompasses two different townships and two different fire protection districts. Because of this, similar campsites may be assessed at slightly different rates based on what township or fire protection district they are located in. Tax bills in Lee County are usually mailed out in April or May of each year with due dates of June and September. A notice is included each year in the *Woodhaven News* when the Lee County tax bills are mailed.

It is important to know these bills are mailed directly to the residential address of the Property Owner listed on the deed. If you, as a Property Owner, ever have a home change of address, you need to contact Lee County Treasurer's Office to provide them with the most current information so your tax bill can reach you. Remember, you are responsible for payment of your county taxes whether you received a bill in the mail or not! We have seen many situations where Property Owners have lost ownership of their lot to non-payment of taxes because the bill was not being sent to the correct address. The Lee County Treasurer's Office can be reached at 815-288-4477; Woodhaven will not be able to answer questions regarding specific tax bills.

Hopefully, this clears up any uncertainty or confusion between the annual association assessments and county tax bills. If you have any further questions, please don't hesitate to contact Woodhaven Association's Office at 815-849-5209.





As I am putting together my articles here at the end of February for the April *Woodhaven News*, it appears that "spring has sprung." Things were thawing rather quickly late last week and temperatures this week are forecasted to be in the upper 40s! A much welcome relief from the deep freeze we had been in for most of February. I am sure everyone is anxious to get outdoors.

Those that will be coming out over the next few weekends may notice the dredge equipment that is staged in the Bait Shop parking lot. This will be temporary as we wait for the ice and snow to melt off so that the dredge contractor can begin assembling pipeline and other necessary aspects of the project. Remember from past news articles that the lakes scheduled to be dredged are Pine, Hidden and Bluegill Lakes. Be aware that during the project there will be areas on the roads where the pipeline will be crossing so use caution while traveling property. The plan is for the majority of the project to be completed prior to Memorial Day Weekend.

A heads up that those planning to participate in fishing through the season are required to have in possession an Illinois State fishing license. The State has implemented the new Explore More Illinois licensing system throughout the state. The system is up and running in the bait shop to allow Property Owners and guests to purchase a license. As in the past, those coming in for licenses that have not had a license in the past will need to provide their social security number. Those that have purchased licenses in the past should keep their 'old' license as the customer ID number on that license will help speed up the process. Licenses can be purchased at the bait shop on property. See my later article for additional information related to pricing and other specifics.

I look forward to seeing everyone through the season as we celebrate 50 years of camping!

#### LANDSCAPE WASTE PICKUP BEGINS IN APRIL!

With spring upon us, it is the time when most lot owners make their first treks out to Woodhaven after what has seemed to be a looong winter in order to prepare for the upcoming camping season. For most, the first order of business is to rake the lot of accumulated debris. This article is intended to remind lot owners of pickup procedures associated with landscape waste disposal.

The Association provides landscape waste pickup service to its members. This service consists of lot-to-lot loose-leaf vacuum, brush, and bag pickup. Each of these has a designated time period through the season. A schedule is included with this article for your reference.

The season begins April 15 with loose-leaf and brush pickup. Loose-leaf pickup is conducted Monday-Friday during the time period of April 15-May 31 and again in the fall November 1-30. Be sure leaves and other leafy materials are piled along the roadside at the front of your lot preferably, in a row no wider than 8 feet. Refrain from incorporating sticks, dirt, rocks, and litter into the leaves to be picked up by the vacuum. These materials create problems for the vacuum that leads to downtime. Please do not block or restrict the roadway in any manner when placing material along the road to be picked up.

Landscape waste pickup requires that one sign up for the service each time there is waste to be picked up at the lot. This can be accomplished at one of the following locations: Woody's True Value, Administration Office, General Store, and the Main Gate, as well as the app. Each week, signup lists are retrieved from the above locations, compiled, and given to staff conducting the landscape waste pickup.



Brush pickup will be conducted once a week from April 15 to November 30. The same procedure is followed as with leaves. Stack brush at the front of your

lot parallel to the road with the cut ends all facing the same way. Brush pickup is normally conducted on Wednesdays unless circumstances prevent. This service also requires one to sign up at one of the designated locations mentioned above.

<u>Do not</u> put sticks, dirt, rocks, metal objects and litter in your leaf piles. Finally, there is paper bag pick up. Plastic garbage bags will not be picked up. Bag pickup follows the loose leaf pick-up season and runs from June 1 to October 31, which is the time period between vacuum pickup. This service is for leafy material and grass clippings generated during the summer period. When filling paper bags, do not over fill! Bags must be of a weight that one person can pick up and place into the back of a truck. Do not put rocks or trash in the bags to

be picked up. Fire pit ashes can be bagged but be sure they are *cold* with all litter removed before bagging. Paper bags can be purchased at the True Value store. This service also requires that you sign up to have your paper bags picked up.

Paper bags and leaves picked up at lots are taken to the compost pile behind the True Value store. Here the material is allowed to compost or break down into rich soil. The finished compost is hauled out to section 25 at the "woodchip pile" for Property Owner use. There is a limited supply so compost may not be available at certain times.

#### ANNUAL FISHING LICENSE RENEWAL

Remember to renew your Illinois fishing license prior to embarking on that first trip out to the lake, pond, or river beginning April 1, 2021. Your fishing license purchased in 2020 expires on March 31, 2021. An Illinois fishing license is required by all owners and guests that fish Woodhaven Lakes. Owners please inform your guests of this State law and Woodhaven rule. Any anglers that plan to catch and keep trout will also be required

Why is a license required at Woodhaven when this is a private campground? Though Woodhaven is a

private campground, it is a lake association. In Illinois, lake associations are not exempt from the need to have a current fishing license in possession while fishing the lakes on property. The exception to this is the period set aside by the State as FREE FISHING DAYS to be held June 18 to June 21, 2021. During "Free Fishing Days" only, anglers will not be required to have any type of sport fishing license.

Persons not required to have a fishing license are those under 16 years of age and persons legally blind or disabled. Disabled persons residing in Illinois must be able to show proof of disability with an I.D. card available through the Secretary of State driver's license facilities. The card must show a Class 2 or Class 2A disability. A Veteran's disability card is also valid identification for persons that are not required to have in possession a State of Illinois fishing license. Persons on active duty in the Armed Forces are considered residents. A person on active duty in the Armed Forces, who entered the service from Illinois and is an Illinois resident, may fish without a license while on leave.

\*\* Half-priced sport fishing and sportsman's licenses will be available to resident veterans of the U.S. Armed Forces after returning from service abroad or mobilization by the President of the United States. Veterans must contact the Springfield office at 217-782-6302, to obtain a half-priced license. #### LOST, STOLEN, DESTROYED LICENSE REPLACEMENT:

- 1. Licenses purchased via the Internet can be reprinted at no charge by visiting www.dnr.illinois.gov/LPR. Vendor transactions will incur a fee.
- 2. Replacement licenses, permits and stamps are available for \$3 from Regional offices (except Region 2), the Chicago office and the Spring-field Public Service area (see inside front cover map).
- 3. Vendors can issue replacement licenses with a DNR Direct terminal. There is a \$3 replacement fee per item plus a transaction fee.

#### **DISABLED OR BLIND PERSONS:**

In order for disabled or blind persons who are Illinois residents to fish without a license, the person must be able to show proof of disability in the form of one of the following:

- 1. A State disabled person I.D. card (available from the Secretary of State through the driver's license examining station) showing a Class 2 or Class 2A disability. This applies to Illinois residents only.
- 2. Veterans disability card (available from the Illinois Department of Veterans' Affairs Office) Veterans who are at least 10% disabled with service-related disabilities or in receipt of total disability pensions may fish with sport fishing devices during those periods of the year it is lawful to do so without being required to have a license, on the condition that their respective disabilities do not prevent them from fishing in a manner which is safe to themselves and others. This applies to both Illinois residents and non-residents.

#### **INTERNET LICENSE PURCHASES:**

To purchase fishing and hunting licenses and stamps over the Internet, please visit the Department's Home Page at: <u>http://www.dnr.illinois.gov</u>

Watercraft renewals may also be done at this site.

Licenses can be purchased on property at the Woodhaven Bait Shop (located at the West end of Nature Center) or off property at Amboy Sporting Goods located on Main Street in Amboy as well as ACE Hardware in Mendota, IL.

#### WATERCRAFT REGISTRATIONS

Any watercraft powered by a motor (electric or gas) or sail are required to be registered with the State of Illinois Department of Natural Resources. This includes watercraft using electric trolling motors. Registration forms may be acquired from any boat dealer, Department of Natural Resources office or online at the Illinois Department of Natural Resources website list-





ed above. Registering on-line is by far your quickest way to register. These registration stickers are valid for 3 years.

Owners of boats stored or used on Woodhaven property including: deck

boats and sailboats must display a current registration sticker on their watercraft, if required, as well as the section and lot number on the outside. Pontoon/deck boats used upon the lakes are not allowed to exceed 16 feet total length as measured on the pontoon deck or stated on the watercraft title.

It is very important to put your section and lot number on the outside of all watercraft.

#### **WOODHAVEN BAIT & TACKLE SHOP**

The bait shop will be open for business beginning the weekend of April 3. Since this opening weekend is Easter, the shop will be open only on Saturday, April 3, 7 am-4 pm. We will have weekend hours only during the months of April and May up to Memorial Day weekend.



### **ESAC Corner** The Function of the ESAC Department

We frequently see Property Owners posting questions on social media to which the response is, "call ESAC." While we are happy to answer your questions, perhaps clarifying our function will help direct your calls and questions more accurately.

The ESAC Office has three basic functions: construction permits, lot inspections and maintaining contractor and vendor lists.

Construction permits need to be obtained whenever placing, building or altering any improvements on your property. When a permit is obtained, an ESAC Inspector will make periodic inspections of the property to make sure the improvement meets the guidelines established in the Rules and Regulations. During the height of the season, there can be 700+ open permits that need to be continuously monitored. Should you have any questions about any construction guidelines, if an improvement is allowed or if an improvement requires a permit, we are here to assist you in obtaining the accurate information.

Lot inspections are primarily done as a result of a pinning request, permit inspection or violation follow-up. Follow up inspections are done on a 30-45 day rotation. We request that violations be corrected within 30 days of the date of notification however should you receive a violation notification that you are unable to correct within that timeframe, simply call our office to discuss your plans for compliance. We are happy to allow additional time if needed.

Contractors and vendors are required to register with the Association. The ESAC Office is charged with registering contractors and vendors, maintaining the contractor and vendor lists and verifying contractors carry current liability insurance. While contractors and vendors are registered with the Association, they are not "approved" or "recommended" by the Association or the ESAC Office. They have simply paid a fee and provided adequate insurance. It is always recommended that the Property Owner obtain a written contract prior to any work being done or payment being made. If you should have issues with any contractor, we recommend completing a Speak-Up Sheet which will be placed in the contractor's file. Any contractor that receives three Speak-Up Sheets within a calendar year will automatically have their privileges reviewed by the ESAC Board of Review and Board of Directors. Property Owners can also call the ESAC Office to inquire if a contractor has received any written complaints (Speak-Up Sheets).

One of the most common misconceptions is that ESAC handles issues with trees, vegetation or common areas. While tree removal permits can be obtained in our office, the approval or denial of the permit is handled by our Resource Department. The Resource Department would also be able to address your concerns regarding oak wilt trees or maintenance and trees or vegetation in the common areas. Because it is a small department and their job duties require them to be on property for most of the day, the ESAC Office assists by helping Property Owners fill out tree removal permits and answering phone calls if possible. If a question is beyond our knowledge, we will forward the Property Owner to the Resource Supervisor for further assistance. Catching someone in the office can be difficult, however they will return your call as soon as they are able.



The ESAC Office also frequently receives calls regarding water hydrants, specifically leaking water hydrants. Issues with the water and sewer service are handled by our Utilities Department. Much like calls regarding trees, our office will attempt to assist the Property Owner to be best of our ability however some questions may need to be forwarded to the Utilities Supervisor.

And finally, questions regarding assessments, the number of your overnights stays or guest lots would need to be addressed by the Administration Office. The Administration Office would have the most accurate information regarding these types of questions.

The ESAC Office is always available to answer your questions or will forward you to the appropriate department if needed

"April showers bring May flowers!" How many of us remember learning this phrase when we were children? We believed that the rains would help the flowers grow and this phrase helped to get us through some of the cloudy, rainy days; there is truth to the phrase but where does it come from? Historians believe that the phrase comes from a poem which contains the lines "Sweet April showers, do spring May flowers." The quote comes from Thomas Tusser in a collection of writings he published in 1557 called "A Hundred Good Points of Husbandry." The quote was in the April Husbandry section. A longer phrase, "March winds and April showers bring forth May flowers," has been traced back to 1886. During these times, especially in the United Kingdom where Tusser was from, it was common for April to be a rainy month. Around our area, I believe the adage is true as typically a majority of our spring woodland flowers start to really bloom in late April and early May. Of course temperature and amount of daylight also play a large role in when flowers bloom as well. So, let's hope for rain this month and warmth so that the May flowers will bloom beautifully this spring!

#### **New in Nature**

Phenology is the study of the timing of biological phenomena in nature! To learn more about phenology, revisit this article in the March *Woodhaven News*. You and your family can track phenology in your own backyard by starting a nature journal. Keep track of what you see and when, or write your observations in a calendar.

Keep your eyes open in April for continuing ducks and geese migrating through Illinois and some staying and starting to nest. Watch for shorebirds like dunlin and least sandpipers to start coming back through on their way to Canada to raise their young. While a few robins stay year round in our area, expect to see large numbers of them in April before they continue to spread out around our area and further north all across Canada. Many of the Bald Eagles will have left the area to northern climates by now, so the ones that still around are the ones that live year-round in the area and hopefully have hatched chicks or will be soon. Listen for the frogs starting to call around lakes and ponds, the first of the season being the spring peepers and northern chorus frogs. The first flowers of spring should be appearing including the skunk cabbage (picture shows the flower before leaves show up) in early April and spring wildflowers especially by mid- to late-April. During the month of February we saw Bald Eagles continuing in large groups on the Mississippi and Illinois Rivers and the local ones working on their nests by adding extra branches. In early February we experienced a colder than normal temperature shift due to the jet stream moving further south. This arctic blast brought high temperatures from -1 to 15°F and lows from -13 to 0°F, when adding the wind chill making the temps closer to -35°F in some locations. During this cold blast, the region also saw the snowiest three weeks since January 1979 and a complete whiteout on February 4th with snow blowing and winds up to 52 MPH in the area. Near the end of the month, large flocks of the blackbird family started to make their way back to the region. While a few stick around all year, we started to see 1000s of red-winged blackbird, common grackle, and brown-headed cowbirds. These birds are singing their spring songs.
