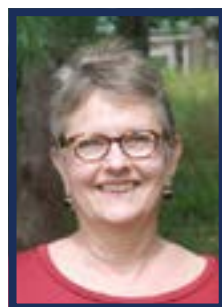

president's letter

Woodhaven Improvements

Our Board agendas indicate under new business and old business Woodhaven improvements and projects. Take, for example, we discussed Pickleball courts and Wading Pool Resurfacing. Woodhaven ensures it maintains it's current assets, as well as identifying new ones.

Why is this important to you as a Property Owner? It's important because we need to maintain the condition of our current assets to ensure safety and functionality for you as a Property Owner. It is also important to identify new assets or services; an example would be the Disc Golf Course. It adds a new amenity that Property Owners have been asking for, and provides an additional activity for a diverse Property Owner population. It is necessary that the Board, the Committees (comprised of Property Owners) and the Management Team always strike a balance between maintaining and having an eye towards the future. This business practice will keep our Association healthy by continuously improving.

The maintenance and future planning for these projects are transparent and consistent. All of them are put on a schedule and the schedule is consistently reviewed on an annual basis for prioritization. Annual meetings are held to

review the results of the project schedules and planned budget, which are then posted on our website. We have two committees comprised of Property Owners and Management that serve as a major planning and review function for Woodhaven, the Finance and Facilities Planning Committees. These committee members not only serve their committee, but also provide input during our annual budget planning workshop.

I share this process with you because we do have a lot of new Property Owners who ask why certain amenities are added or what the process is. If in doubt, please seek out the Woodhaven website or attend a Board Meeting or view the recorded Board Meeting.

We have a goal to make sure Owners are well informed about the services, events, and activities taking place at their Association. We also want to ensure everyone has access to accurate information on these activities, our governing documents, policies, and procedures and offer the following suggestions to both new and seasoned Owners.

As Woodhaven transitions into the busy camping season, other big changes are happening as well. Mike Hogan, General Store Manager for the past 13 seasons, has announced his retirement.

Mike was a Property Owner long before an employee, when he first visited Woodhaven in 1984 with some friends, he fell in love with the natural beauty and serenity. He purchased his first lot in 1985.

"I remember back when I bought into Woodhaven, most of the roads were still gravel, the bank was located in a trailer on property and we had to wait in long lines for donuts at the original General Store," Mike recalls. "I love Woodhaven. It's been such a huge part of my life, both personally and professionally."

Even before Mike became the General Store Manager in 2009, he was helping shape Woodhaven's future through volunteer work on several committees. Mike was a member of the Communications Committee for 15 years, the Marketing Ad Hoc Committee for four years, and the Strategic Planning Committee for three years. Through his work on the Strategic Planning Committee, he helped spur some of the biggest improvements and changes to Woodhaven since it was first developed. This Committee was responsible for initiating design and development of the RecPlex area, including renovation of the Pavilion, renovation and repurposing of the old General Store into the RecPlex Building, building of the mini golf course, and construction and placement of the current General Store.

Professionally, Mike worked in sales for Harcourt Publishing and in international marketing for World Book Publishing Company before taking the helm at Woody's General Store. He and his wife Eileen, along with their two children, Brett, 20 and Brian, 17, still plan on enjoying plenty of time at Woodhaven, just at a little slower pace.

Although Mike will be passing the torch, you may still see him in the General Store this summer in a part-time capacity helping with the transition for the new General Store Manager Jonathon Quintana and directing some excellent specialty theme dinners at the Restaurant.

"I have so many great memories at Woodhaven that it's difficult to narrow them down to just a few," Mike says. "One thing I can say, though, from an employee standpoint is just how great staff here work together and support each other."

For New Property Owners

If you are new to Woodhaven, perhaps within the past two years? Did you receive copies of the Covenants, By-Laws, and Rules? For Seasoned Property Owners

Perhaps you been in the Woodhaven family for a while; or at least long enough to have misplaced your copy of the Covenants, By-Laws, and Rules? Maybe you simply do not remember what permits are needed for improvements, or what is and is not allowed in the dumpsters. Or maybe you have changed your address and/or phone number but have not informed the Association of these changes? Did you know this can be taken care of on the Woodhaven website? Our website, mobile app, and the Woodhaven Lakes Facebook page are effective and reliable resources to send and receive information from. We also recognize and support nothing can replace receiving this information from a real, live person! For all your Woodhaven needs, we welcome and encourage calling the office at 815-849-5209 or e-mailing us through the "e-mail us" links on our website at www.woodhavenassociation.com.

Upcoming Projects

While the calendar says Spring is here, we are not too sure if mother nature has come to terms with this fact just yet. Regardless, as the weather improves, Association staff members are working to prepare the property for a successful summer season. These tasks range from the routine to projects specifically targeted within the year. While many will be completed on schedule and/or consistent with past practice, others may be impacted by known and unknown challenges where delays occur, and adjustments are needed. A sampling of these tasks include:

- Interviews for part-time positions are taking place in multiple departments to cover critical portions of our operations. We are looking forward to working with those returning to our staff and with those who are new to the Association.

- As we move from the winter season, many areas of the property require cleanup including, roadsides, parking lots, landscape beds, trails, guest lots, and other common areas. The leaf vacuum and brush pickup programs are also gearing up to support your spring-cleaning efforts and our moving crews have begun their weekly routine.

- Facilities have been opened for the season or will soon be opening and include all of the comfort stations, the General Store, the Restaurant, the Rec Plex, mini-golf, and the pools and beach.

Specific projects budgeted for the year include:

- A paving project will be taking place at the Maintenance location in Section 9 to improve the unacceptable material drop-off compound. This project is part of a comprehensive plan to add fencing, cameras, and gate controls, which will be installed later in the year.

- Gravel and fill materials from the paving project will be utilized to prepare a pad for the air burner box system. Delivery of this item is targeted to be in October / November.

- In addition to the air burner, we are scheduled to purchase a firewood processor which is also expected to arrive in the October / November time frame.

- Aquatic and recreation projects include the disc golf course noted last month, some new game machines in the Rec Plex, new paddle boats and kayaks, along with improvements to the surface of both wading pools at our aquatic facilities.

- Road program funding allows for seal coating and striping of the parking lots at Pool 2/Beach and Nature Center/Bait Shop. Funding is also available for road patching and to replace approximately 80 road signs. An example of the new road signs can be seen when you come through the main gate on the righthand side as the Woodland Trail sign has been replaced.

- Other projects include replacing the front gate equipment, improvements to Comfort Station 6, HVAC equipment replacements, replacing the upper deck railing at the Lakeview Building, steel siding on the guard house shed, and replacing the roofs at Comfort Stations 10 and 25.

- Funding is provided for shoreline erosion and protection associated with the stream entering Woodhaven from the south and running between

Sections 8 and 9 to Bass Lake. Owners should anticipate seeing work on this project in the late summer and fall months of the year.

- Other areas with improvements include the Section 4 playground, installing culverts to remove the ditch near the Rec Plex courts, converting a tennis court to multiple pickleball courts, and removing the dredging sediment from the overflow parking area for the Beach, Family Center, and Pool 2.

We definitely have a full schedule and are looking forward to getting these tasks completed.

Not only are we busy with projects and improvements; we also have a full plate of administrative tasks to tackle. Two of these include the Aquatic Splash Park Referendum process and a Board of Directors election.

Aquatic Splash Park Referendum

The referendum process is nearing its completion with a Town Hall discussion taking place on Saturday, April 23, 2022, 10:00 am at the Rec Plex. Ballots will be mailed during the week of April 25th with a requested return date prior to the June 11th deadline when the ballots will be counted. Members of the AORC Committee will also be available during the open market on Memorial Day Weekend to answer questions about the proposed project.

Applications for Board of Director Open Seats

As of April 1, 2022, affidavits for the open seats on the Board of Directors are available online or at the Association Office. The deadline to return the affidavits, autobiographies and position statements is Saturday, May 14, 2022. There are four openings on the Board for this Election. Updates and additional details about this election process will be published in future issues of the Woodhaven News. The results will be announced at the Annual Meeting on August 21, 2022.

Some additional Notes and Updates

- Assessment collections rates are consistent with past years. At the first installment due date we had collected 71% of the dues with approximately 3,500 lots paying in full by this date. For those choosing the install-

ment payment option, the second installment is due on or before May 31, 2022. A \$25 late fee will be added to all account balances exceeding the 3rd and final installment payment due on or before July 31, 2022. Thank you to everyone who has made their payments to support our operations and activities.

- The Board of Directors accepted the discount agreement with Shady Oaks Country Club. Owners and guests of Owners who provide Shady Oaks CC with a Woodhaven pass will receive a \$5 discount per nine holes throughout the 2022 season.
- The 2022-2023 Annual Budget was approved by the Board of Directors at the March 28th Board Meeting. Copies of the budget documents are posted on the Association's website and available for Owner review at the Association Office. Owners choosing to request a printed copy of the budget documents will be charged a fee to cover printing costs.
- The Association's general liability and workers compensation insurance program was approved by the Board of Directors at the March 28th Board Meeting. The total premium costs for liability coverages increased by about 2.1% to \$148,650, with a larger increase to workers compensation insurance which increased by about 31.9% to \$71,207. The work comp increase is claims driven as our experience mode increased from 0.82 to 1.10.
- Auditors from Wipfli have begun their annual review process. Onsite fieldwork is scheduled to take place in early May while offsite will continue through June and July to prepare the final year-end reports. A copy of the final report will be posted on the Association's website with the short report included in Woodhaven's 2022 Annual Report. The Annual Report will be available at the Annual Meeting on August 21st, and a copy will be included in the September issue of the Woodhaven News.

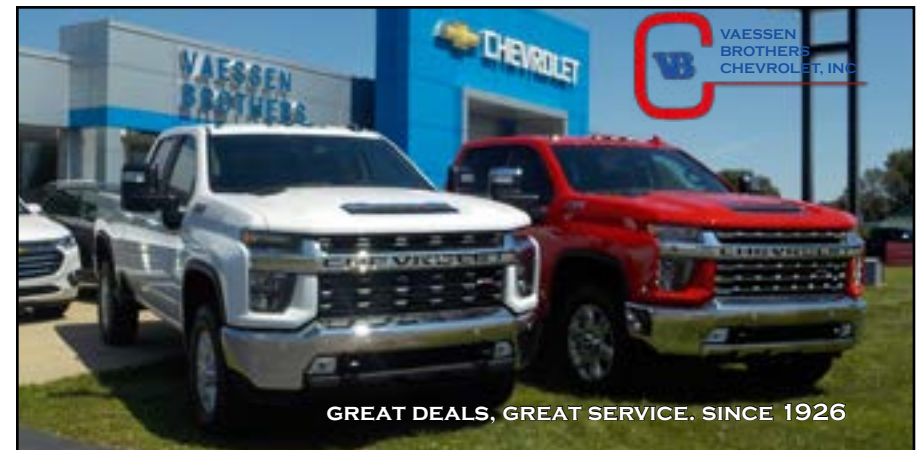

2. Motion was made to approve the air burner box system project for a not to exceed cost of \$210,000. Motion passed unanimously.

6. Motion was made to approve the Resolution Adopting Policy Manual Changes – 08-200-0220. Motion passed unanimously.
7. Motion was made to approve the bid from Bell Rock for the parking lot seal coating for a cost of \$13,224. Motion passed unanimously.
8. Motion was made to approve the bid from Martin & Co. for the unacceptable material compound for a cost of \$147,831. Motion passed unanimously.
9. Motion was made to approve the bid from Mid America Pool Renovation to repair and resurface both wading pools for a cost of \$24,720. Motion passed unanimously.
10. Motion was made to approve the bid from Blockbuster, Inc. for the purchase of the wood processor for a cost of \$80,028 and the bid from Dyna Products for the purchase of the bundler for a cost of \$3,931 with a not to exceed total cost of \$85,000. Motion passed unanimously.
11. Motion was made to approve the bid from John’s Sales and Service for the walk-in cooler at the General Store for a cost of \$14,554. Motion passed unanimously.
12. Motion was made to approve the Shady Oaks Corporate Discount Agreement. Motion passed unanimously.

PRELIMINARY SPLASH PARK DESIGN & INFORMATION

New Aquatic Facility?

Over the years Woodhaven Lakes has been met with many membership service needs and demands that, when given enough time, resource, and planning ultimately achieved those Property Owner desires and interests. At Woodhaven’s core, the two swimming pools and lakefront beach have always been of the highest priority of all facilities utilized, followed closely by the lakes (more water!).

Busy, crowded, congested, and, at times, crazy tends to describe any given summer weekend at the aquatic facilities and on the holiday weekends, overwhelming. Recent operational adjustments requiring reservations, limiting use, and allowing for more members to participate at the facilities on the weekend have helped ease this tension.

For 15 years, relieving the present burden placed on the pools and beach, while providing additional aquatic oriented recreation different from our existing, has been the drive of the Facilities Planning Committee bringing about the Aquatic Splash Park of today.



SITE PLAN



Where and Why?

An Aquatic Facility Site Analysis was completed by engineers from Water Technology Inc. in September of 2014. Best potential locations for an additional aquatic facility were identified and weighted for Solar Orientation, Utility Access, Topography, Geotechnical, Parking Areas, and Potential Destructions. Those areas were right next to Pool One (referenced as Site 1), the open field near the Woodhaven Lake Complex (Site 2) commonly known as “the overflow parking” for the Beach/Pool Two, and the open common area in Section 25 (Site 3) also known as “the woodchip pile.”

Disadvantages were subtracted from advantages in these areas with Section 25 (Site 3) being recommended 1st with 14 points, Overflow Parking (Site 2) with 13 points, and Pool One (Site 1) with 8 points. It was also noted by the Facilities Planning Committee that Section 25 (Site 3) was weighted negatively for “location not central”, which committee members considered to be a positive and more in line with their interest to more evenly distribute activities and populations across the property (not add more people to areas that are already heavily populated with users).

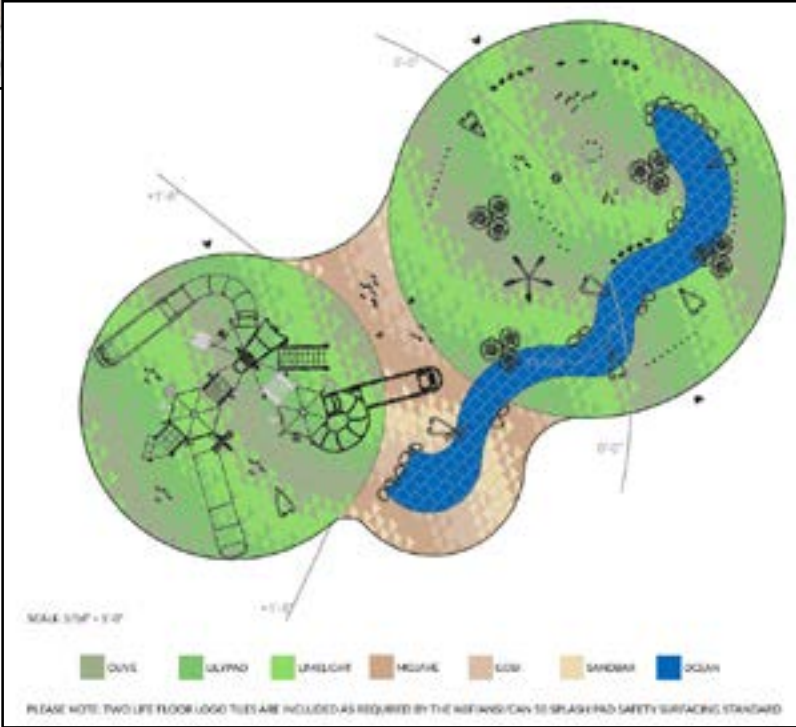
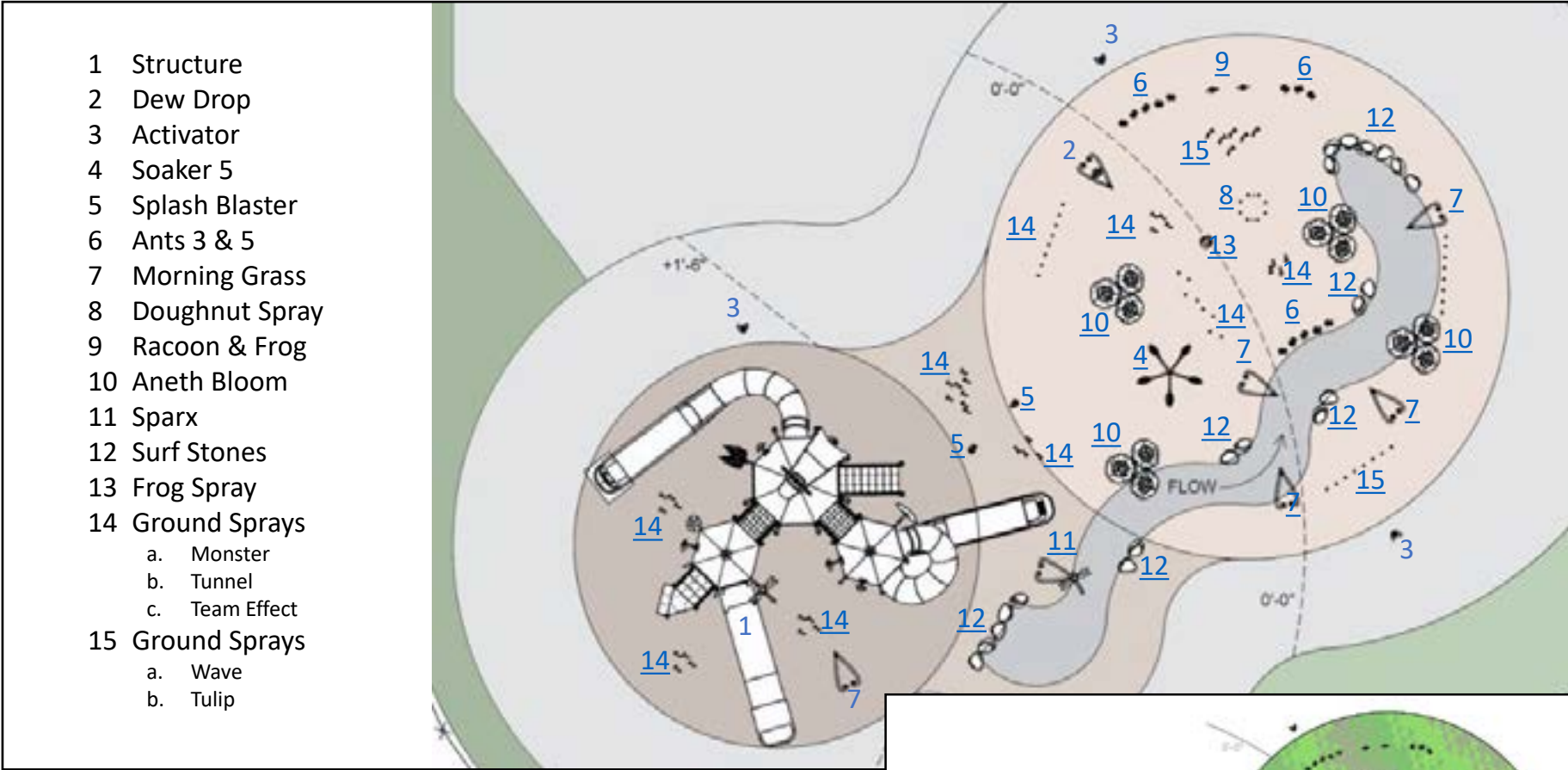
Two additional considerations unique to the Section 25 location also supported the committee’s recommendation. Those are enhanced access to the Preservation Area just across Woodhaven Drive West in Section 28, and the surplus space in the Section 25 common area for potential future growth. Future growth may include the grass walk paths throughout these two areas to be improved with gravel trails. Under the protection of Woodhaven’s Covenants and Restrictions, Preservation Areas (Section 28) cannot be developed with any sort of amenities however, opening up these 20+ unknown and forgotten acres of Woodhaven’s nature to hikers, bikers and nature programs is encouraging.

How do we pay for it?

As it is a new project being considered, funding for the proposed Splash Park does not exist in the present day Woodhaven Association budget, or its 12 million dollar reserves. The initial 4.5 million dollar construction cost would arise from an internal loan from those reserves, and paid back to those reserves (with interest), over the next 15 years. The new facility will need to build reserves for future care and replacement over the next 30 years. In addition to the reserves, projected annual operating costs (staff, utilities, etc.) of \$120,000 (with inflationary increases) would need to be added to the budget. These combined amounts would directly relate to about a \$90 annual increase in assessments.

Will this Splash Park require licensing and approval from the Illinois Department of Public Health, regulated by State of Illinois Administrative Codes (similar to the pools and beach)?

What questions do you have? What are your thoughts in support, or not in support, of this potential new addition to Woodhaven Lakes?

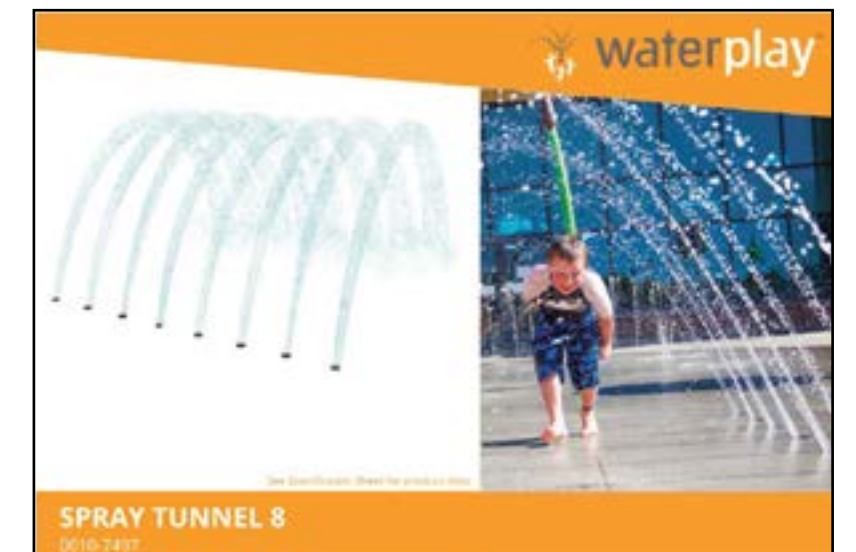
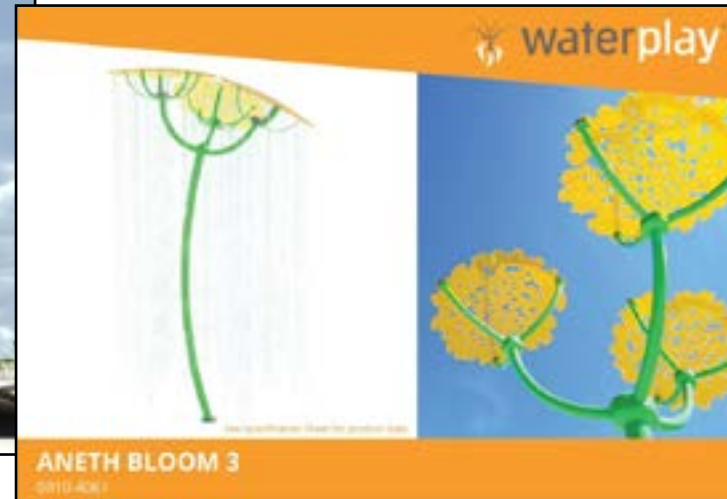
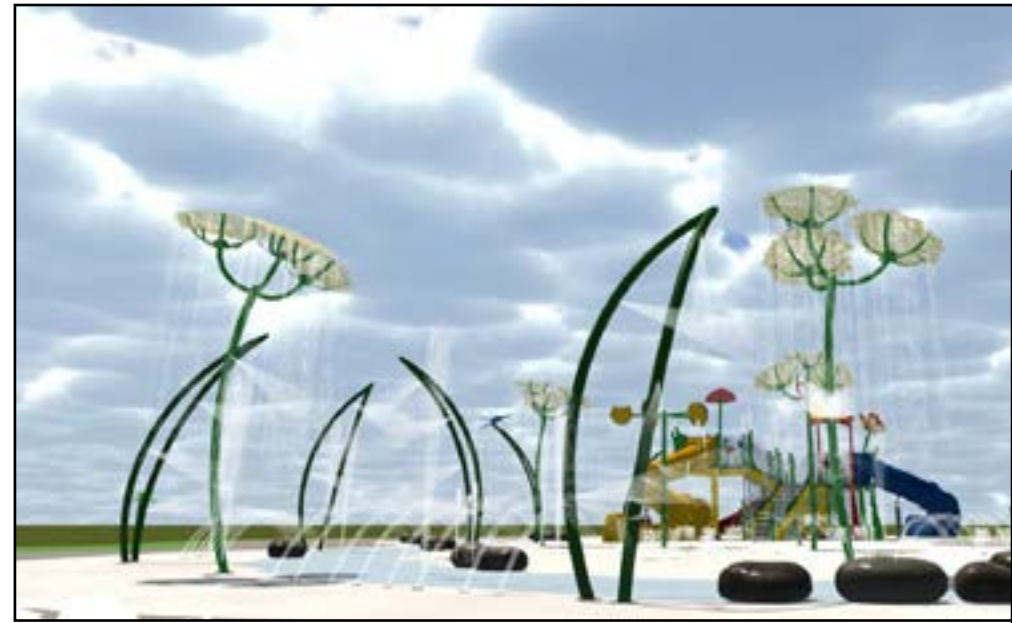

RESTRICTED MATERIALS PROCEDURES

In order to provide Owners a way to dispose of restricted items in the refuse industry, we have provided roll off dumpsters at the Maintenance Shop; dumpsters are accessible 24/7. Please make note of limits and pricing. Items that have a fee will need to be paid for at the Association Office prior to be taken to the dumpsters.

Materials we will accept
Appliances(white goods): Refrigerators, freezers, ranges, water, heaters, air conditioners, and humidifiers; **1 per lot**
Electronics: laptops/monitors/keyboards; **3 per lot, \$5 per item**
TVs: 1 per lot, \$25
Microwaves: 1 per lot, \$5
Propane Tanks: 20 pound cylinders only; **1 per lot**
Concrete: We will accept a wheelbarrow-sized load or smaller
Furniture: We will accept all furniture unless it is determined to be a health hazard; **3 per lot**
Metals: Large; **1 per lot** | Small; **5 per lot**
Large - lawn mowers, grills, swing sets, patio sets
Small - lawn chairs, lawn ornaments, bird feeders
Construction/Demolition Debris: we will only accept small amounts, for example, a wheelbarrow-sized load; **limit 1 load per lot**, or bring extra loads at a cost of \$5.00 per wheelbarrow load. The material must be clean, no nails, spikes, staples, etc. Property Owners are required to obtain their own container from a waste hauler for construction or demolition projects generating larger amounts of debris.

Materials we will NOT accept
Hazardous chemicals: paint thinner, turpentine, herbicides, pesticides, fertilizers, etc- contact your local recycler
Liquids of any kind: anti freeze, fuels, etc – contact your local O’Reilly’s, AutoZone, or car service center
Oils: motor oil, vehicle lubricants, cooking oils, etc- contact your local O’Reilly’s, AutoZone, Tire/Lube Center
Unsolidified paint: Oil based: contact your local recycler, Latex: cat litter or paint hardener to solidify (available at Woody’s True Value)
Tires: Contact your local tire dealer
Batteries: Contact your local Radio Shack, Home Depot, Staples
Fluorescent bulbs: contact your local Home Depot, Lowes, or Battery Plus Bulbs center

Any of the above items that are brought to the drop-off will be marked by staff so their origin can be identified if found in an outlot or in or near a garbage container.

NOTICE

UNACCEPTABLE MATERIALS AT THE LANDFILL

DO NOT DISPOSE OF THE FOLLOWING ITEMS IN THE GARBAGE CONTAINERS:

- Appliances
- Batteries
- Hazardous Chemicals- Paint thinner, turpentine, mercury, etc.
- Oils- Vehicle lubricants/fluids, undrained filters, etc.
- Full Paint Cans
- Landscape Waste
- Construction Debris- Roofing material, block, lumber, railroad ties, etc.
- Electronic Equipment- Computers, TVs, monitors, printers, stereos, cell phones, etc.

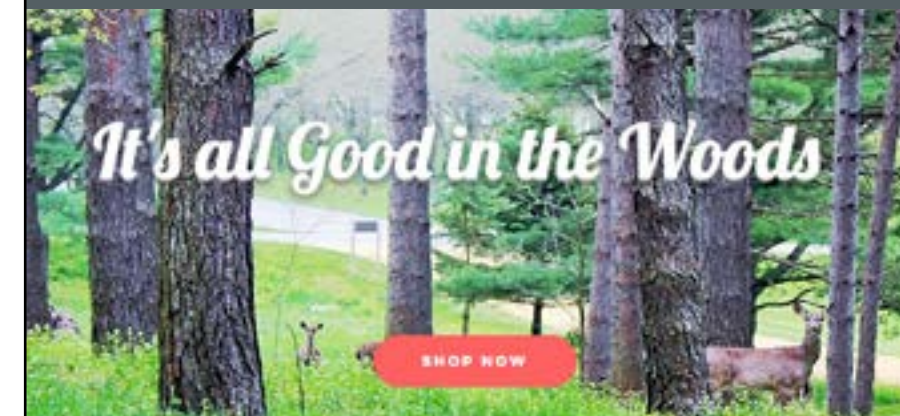

SECTION 4. QUALIFICATIONS OF

RESOURCE POINTS TO BE AWARE OF IN THE COMING SEASON

- Vacuum leaf pickup runs from April 15 through May 31. Rake leaves and other yard debris, excluding sticks, dirt, trash and rocks, to the front of your lot. Brush pickup will begin on April 15 and extend through November 30. Stack brush at the front of your lot. Sign up for all landscape waste pickup at the Service Center, Gate, Administration Office, General Store, or the app.
- Keep all fertilizer and pesticide applications away from the lake at least 25 feet as stated in our Rules & Regulations. Better yet, apply a fertilizer with no phosphorus in the formulation. Phosphorus is one of the key nutrients leading to excessive growth of nuisance aquatic vegetation. Ask for phosphorus-free fertilizer formulations at garden centers. You can determine the phosphorous content in the ingredient formulation usually found on the front of the bag in the form of 10-0-10. These numbers give the percent of nitrogen (N)-phosphorus (P)-potassium (K) respectively.
- Please do your part by not feeding the GEESE or any of the 'wild' animals that visit our property. Report any goose nests you find to the Resource Department at extension 305.
- Be aware that beaver inhabit our property and Property Owners need to protect their valued trees along the lakes. These animals can show up at any time on any of the lakes. The Resource Department traps beaver and muskrat during the designated state trapping season in the fall each year to control numbers of these animals.
- Fishing licenses expire March 31 of each year. Remember to renew your fishing license for the 2022 season beginning April 1, 2022. Anyone 16 years of age and older actively participating in angling is required to have in possession a current State of Illinois fishing license while on Woodhaven lakes. The exception to this will be during the period set aside by the State as FREE FISHING DAYS. This period is set for June 18, 19, 20 & 21 for this season. During this period only, anglers will not be required to have any type of sport fishing license. Anglers will be required to follow all other fishing regulations.
- All motorized watercraft i.e. electric trolling motors used upon the lakes must be registered with the State of Illinois Department of Natural Resources (IDNR). Registration forms may be acquired from any boat dealer, Department of Natural Resources office, or the preferred method is to register on-line at the IDNR website, www2.illinois.gov/dnr. Owners of non-motorized boats: canoes, kayaks, paddleboats, and paddleboards are no longer required to have a Watercraft Usage Stamp. Boats used upon the lakes are not to exceed 16 feet total length. Paddle boards are allowed on the lakes. All watercraft are required to display owner's section/lot numbers on the outside. Gas powered motors are not allowed on boats when on the lakes even if they are not being used.
- Watercraft storage areas on Bass, Black Oak and Woodhaven lakes are on a first come first serve basis. Watercraft can only be stored at these loca-

tions between March 1 and December 1. All watercraft must be removed from all storage areas and common ground December 1 to March 1 each season.

- Refrain from trimming oak trees during the active growing season, April-October. Trimming during this time aids in the spread of oak wilt disease.
- As a reminder, residents of Illinois are not allowed to place feed or salt/mineral blocks out to attract deer. This practice was banned by the Illinois Department of Natural Resources a number of years ago due to the outbreak of Chronic Wasting Disease in deer populations in Wisconsin and several Northern Illinois counties. With the continued spread of CWD, it is important to refrain from intentionally placing these items out for deer. Any of these found on properties in Woodhaven will be removed! Please help to stop the spread of this disease by not placing these items out on property.
- The first positive CWD deer was found in southeast Lee County during the 2020 fall/winter hunting season. This was approximately 8 miles east of Woodhaven. This is an important reason to consider some type of deer management on property. Deer numbers are high in and around Woodhaven property.

How to Display The American Flag

The U.S. flag stands for our nation and the shared history, pride, principles, and commitment of its people. When we properly display this powerful symbol, we signal our respect for everything it represents.



The flag shouldn't be flown in inclement weather unless it's an all-weather flag.



Flags displayed at night should be properly illuminated.



In a time of national mourning, hang the flag at half-mast.

The flag can be flown every day, but it is often flown to show patriotism on these observances:

When displaying the flag ...



From your porch, place the union (blue section) at the peak of the staff.



Against a wall or on a window, place the union (blue section) at the top left corner.



On your vehicle, clamp the staff to the right front fender.



With another flag, place the U.S. flag to your left when crossed.



Keep your flag completely dry and folded properly — into a triangle, with the union (blue section) visible — before storing it in a well-ventilated area. If the flag is damaged or worn out, it should be disposed of with dignity.



The flag should not touch anything below it or rest on the ground.

Beware of Invasive Species! Our focus this month will be on a couple of invasive species of birds. (If you would like to know more about the difference between invasive, native, and nonnative species, please refer to the April 2022 Naturalist Corner newspaper article.)

House Sparrow and European Starling are two very common species of birds that can be found around the United States, as well as around the world. These species are invasive because they adapt quickly to any area and populate areas quickly. These two species are also nonnative, meaning they were not originally found in the United States. There is not much we can do about these invasive species since they are so well established but let's take a closer look at each one.



House Sparrow (*Passer domesticus*) can be found in many places, especially around houses and other buildings. They are one of the most common species of bird found and easily identified. House Sparrows are native to parts of Asia, North Africa, and most of Europe and were introduced to Australia, North America, South America, and parts of southern Africa. These sparrows were introduced to the United States starting

in 1851 Brooklyn, New York. By 1900 the species had spread to the Rocky Mountains. On the other side of the country, introductions of the House

Sparrow took place in the 1870s in San Francisco and Salt Lake City, helping spread them around the West. House Sparrows are currently common across all North America except Alaska and far northern Canada.

House Sparrows prefer nesting in manmade structures rather than natural sites, choosing to nest in eaves, walls of buildings, streetlights, nest boxes, and more. Why are House Sparrows a problem? They can be an aggressive species when defending their nests and will evict other native species from their homes, including Eastern Bluebirds, Purple Martins, and Tree Swallows. These native species will also use nest boxes with specific hole sizes. It is important to watch which birds are using your nest boxes and remove the House Sparrow nests if you confirm it is this sparrow. Sparrows will build their nests on top of the other birds' nests and eggs, harming the native species. Please note, this is one of a very small number of bird species that you are allowed to remove the nests – only because they are not native and are not protected by the Migratory Bird Treaty Act and other laws in the United States. Also, House Sparrows have been known to steal food from other species of birds, including robins.

European Starling (*Sturnus vulgaris*) can often be found in cities/towns, lawns, city parks, and farm fields. This is another quite common species found all throughout North America. Originally this species is native to Asia, parts of North Africa, and like the name states, Europe. European Starlings were introduced to North America in the early 1890s, all thanks to Shakespeare enthusiasts! 100 birds were intentionally released in New York's Central Park by a group that wanted Americans to have all the birds that Shakespeare ever mentioned. They are now one of the continent's most numerous songbirds, with more than 200 million from Alaska to Mexico.

Starlings are amazing vocal mimics as an individual bird can learn the calls of up to 20 different bird species. European Starlings will nest in any type of cavity, typically in a building or old woodpecker hole, but occasionally in areas like traffic signals and streetlights. Why are European Starlings a problem? Like the House Sparrow, the starlings can be extremely aggressive towards other birds to drive them from good nest sites, making it difficult for native species to successfully nest and raise young. These native species can include bluebirds, owls, and woodpeckers. European Starlings will also cause damage to farmers crops and berries, eating these items. And finally, for some people, the starling is just too noisy, loud, and annoying. This is especially true during migration and winter when large flocks group together.

So, while these are only two of approximately 100 nonnative bird species in the United States, they are the ones that are more invasive, most common, and have the largest populations.
