Pets have always been an important part of our families and homes. And more and more, our furry little friends have become deeply woven into the fabric of everyday life outside our homes. There aren't too many public places we go, from the local home improvement store, outdoor café, or public park, where we don't see someone walking, pushing in a stroller, or carrying in a backpack, their cherished pets. The fact is, it has become much more socially acceptable to take our pets just about anywhere, and that has also slowly, and deliberately, become the norm at Woodhaven as well—for several reasons.

At Woodhaven, we have always had a set of rules, regulations, and policies regarding pets. Many different types of pets are allowed into our community, including dogs, cats, and caged birds—with limitations. Per our Covenants & Restrictions, which were established in 1971 when Woodhaven was founded, "no more than two dogs, cats, or caged birds may be kept on a Campsite, provided however, that they are not kept or maintained for any commercial purpose."

With more than 6,000 campsites very close to each other, it is understandable why such pet restrictions were established. While many Property Owners may be pet owners and lovers themselves, others may prefer pet-free environments for personal reasons. Throughout the years, additional pet rules were enacted to further expand and clarify policies regarding pets both on individual campsites and in common areas and at community events.

With regards to pets in facilities and at community events, our current rule reads as follows: "Pets are prohibited from being in facilities and/or in the vicinity of scheduled events, as determined by staff, unless otherwise specified. Excluded are service or assistance animals and those used by law enforcement officials."

There was a time just a few years ago when pets were strictly prohibited from all our indoor facilities, and from events and gatherings such as live entertainment at the Pavilion and other recreational activities. "No Pets" signs were placed at these events and common areas, and both Public Safety and Recreation staff would be required to confront Owners and guests and ask them to leave the area with their pets. Over the years, as the social acceptance of pets in public areas began to loosen and become more commonplace outside of Woodhaven, these interactions between Woodhaven staff and pet owners became much more confrontational and combative.

Another factor, which often made it very difficult for staff to appropriately, fairly and most importantly, legally control animals in common areas and events, was when an owner identified the dog as a Service Animal. A Service Animal is defined as a dog that is individually trained to do work or perform tasks for people with disabilities. Service animals are working animals, not pets.

Once a dog is identified by its owner as a Service Animal, we must allow it to remain by law. In the past, we would require, per written Association policy, that the owner of a Service Animal register the animal with the Association, provide documentation and verification of the disability-related need of the dog, and issue an identification tag for the dog so staff could visually determine that the dog is a Service Animal registered with the Association.

Last year, upon further review and investigation of Americans with Disabilities Act (ADA) laws surrounding Service Animals, we discovered that our written policy requiring registration and much of our direct questioning of owners of self-identified Service Animals was in direct conflict with the laws and clarifying informational directives provided by the ADA. Many of the main clarifying points by the ADA regarding Service Animals include:

- Service Animals ARE NOT REQUIRED to wear an identification vest;
- The ADA has NO requirements for Service Animals to be certified or registered;
- The ADA does NOT require Service Animals to complete official training programs;
- Service Animals can be ANY BREED of dog;
- Service Animals DO BARK;
- Individuals CAN have more than one service animal at a time;
- Service Animals CAN BE CARRIED by their owners;
- Staff CANNOT ask about a person's disability, require medical documentation, require a special identification card or training documentation for the dog, or ask the dog to demonstrate its ability to perform the work or task.

As you can see from the above points, it is very difficult to visually determine if a dog is simply a pet or a working Service Animal. And when approaching an owner with a dog, staff is limited to two questions by law, according to the ADA:

- Is the dog a Service Animal required because of a disability?
- 2. What work or task has the dog been trained to perform?

As mentioned, once a dog owner identifies the animal as a Service Animal to staff through direct questioning, the dog is required to be allowed to stay in that location with its owner, even if it is a restricted location for pets.

Based on these points and clarification of ADA laws regarding Service Animals, we recently eliminated the policy requiring Service Animals to be registered with the Association and have relaxed our "No Pets" policy in outdoor venues, indoor facilities and community events. There are still many locations where pets are prohibited, including our pools, beach, and indoor food service areas at the General Store/Restaurant and RecPlex Ice Cream Counter area. Additionally, there may be other areas and specific events where we restrict pets, at staff discretion. These may include outdoor markets, food service areas, or special programs where other live animals are being displayed, such as at the Nature Center. We will make every effort to communicate clearly at those special events and areas where and when we do place restrictions on pets.

Regardless of if the dog is a working Service Animal or pet, they must be under the control of the handler at all times. Pets are always required to be harnessed or leashed on common grounds, both indoor and outdoor, as well as visibly confined by leash or enclosure when on your campsite. On common grounds and at

events, if a dog becomes disruptive or out-of-control, we will ask that it be removed from the area, even if it is identified by its owner as a Service Animal.

As a pet owner, we know you love your pets and cherish their companionship when enjoying and experiencing all that Woodhaven has to offer. We simply ask that you abide by Woodhaven's rules regarding pets and recognize that not everyone is comfortable around animals; and that others might also like to enjoy Woodhaven's amenities pet-free. Our goal is to balance the rights and preferences of pet owners with the needs and concerns of the wider community; and to help create a harmonious recreational environment at Woodhaven where we can coexist peacefully while respecting each other's preferences. Woof! Woof!

#### 2024 Annual Meeting

The 2024 Annual Meeting is scheduled for Sunday, August 25 at 11:30 a.m. at the Rec Plex Multi-Purpose Room. The Annual Meeting is a meeting of the Membership and, according to the Association's By-Laws, is to be held sometime in the months of August or September. All Members are encouraged to attend, but 1% of Members eligible to vote are needed to make a quorum.

The Annual Meeting is an opportunity to learn about your Association's operations, the actions of the Board and management, and to voice your questions, comments, or concerns. The Annual Meeting Agenda and last year's minutes are printed in this issue of the Woodhaven News on pages 24 and 25.

#### Other News and Notes

Paper ballots for the 2024 Board of Directors Election were mailed out mid-July to all Owners in good standing. As during the last election, there is an electronic voting option with instructions for voting by this method included in the mailed ballot packet. If you did not receive a ballot packet by the end of July in the mail and believe you should have, please contact the Association Office.

Many facilities and amenities recently got a fresh coat of paint or stain including the marquee at the Main Gate, the deck at the Nature Center, and the pier at Sunset Lake. The wooden guardrails on Woodhaven Drive across Black Oak Lake are currently being prepped for staining.

The <u>Leisure Times</u> distribution box at the Main Gate was rebuilt with two decks to accommodate easier pick-up from both high and low-sitting vehicles, a great suggestion from an Owner via Speak Up Sheet!

Both parking lots at the Association Office and at the Service Center were crack filled and seal-coated in mid-July. Additionally, 20,000 linear feet of crack sealing was completed on Woodhaven Drive West and Cranhurst Trail.

Main Event Weekend is scheduled for August 2 – 4. Mainstays of the weekend include the Wine, Beer and Cheese Social on Friday, August 2; Open Air Market and Fireworks on Saturday, August 3; and the Car, Truck and Motorcycle Show on Sunday, August 4. We hope to see you there!





With Summer in full swing, we want to remind you about our NEW MEMORIAL TREE program into full bloom! Since the sun has set on the memorial benches, we want to shed some light on the new and improved program. While we all are aware we have lost a few trees over the years due to disease and mother nature, this program is designed to help reforest Woodhaven along with remembering all those lost loved ones who truly enjoyed Woodhaven.

Much like the Memorial Bench program, we will be offering options for location of trees. There are predetermined areas, depending on the type of tree you choose. The purchase of a memorial tree is \$200 and includes a staked plaque to commemorate your loved one. Participants in this program are welcomed and encouraged to assist with care and maintenance of your tree, such as watering, pulling weeds, or pruning broken branches. Please note – no additional "keepsakes" will be allowed to be placed around Memorial Trees.

Location Option 1: Northwest trail of Pine Lake.

• This option will be dedicated as the "Memorial Trail." This location will offer ornamental/flowering trees to create beautiful views while walking along the trail.

Location Option 2: Common Area Reforestation

• This option includes 3 potential locations; however these locations will be in common areas and only allow for hard wood varieties such as oaks and maples. The locations will be designated areas in Sec 29, Mikes Pond in section 6, and Section 8/Section 9 improved trail. These options are designed to help reforest Woodhaven in areas that have been devastated by the tornadoes.


Our first installation of Memorial Trees will be planted late fall/early winter of this year. In order to participate in this round, **orders must be placed by Monday, September 2.**

#### **Five Easy Ways to Avoid Citations**

Having your name appear in the *Woodhaven News* in the ESAC "Citations Issued" column clearly is not how you wish to be recognized. This kind of publicity may be avoided if you follow these five easy suggestions:

- 1. If you receive a letter about a problem or discrepancy and you have questions regarding what needs to be done, call or visit ESAC for clarification. We will be happy to discuss the matter or have an inspector meet with you on your lot to be certain there is no misunderstanding of the problem.
- 2. The letter alerting you to the problem or discrepancy includes an important option: "The issue noted needs to be addressed within 30 days of the date of this letter. If you are unable to comply within 30 days, please contact the ESAC Office to discuss your plans for compliance and a possible extension." Communication with ESAC regarding your plans indicates that you are concerned and want to resolve any problems. ESAC will gladly work with you to answer any questions you may have and provide you with a Violation Correction Agreement allowing you a reasonable timeframe for correction if you are unable to correct the matter within 30 days.
- 3. Once you have an agreed upon timeframe, do your best to keep it. But if, for some reason it is not possible, notify ESAC to discuss options. We certainly understand that weather, emergencies, and personal problems can cause delays and reasonable requests for extension may be possible.
- 4. Be certain your current contact information including phone number and email address are on file with Woodhaven Association. ESAC may need to contact you to be certain you understand the discrepancy, clarify possible problems with the corrections you have made or for any other reason. Sometimes a further a citation is issued because we are unable to communicate with you in any other manner, especially if you have not made contact with our office.
- 5. Also be certain your address information is current. Failure to receive notice of problems because we do not have a current address is not really a valid excuse for failing to respond or correct; and ESAC makes every effort to communicate with you.

If you notice, the words "call," "visit," "communicate," and "contact" are used frequently in the above suggestions. These actions are key to all of the above steps. Staying in contact with the ESAC Office can avoid the issuance of a citation. The goal of the ESAC Office is compliance and not to be punitive to our Property Owners. By working together we can all be "Happy Campers".



# e-bike rules & safety tips

With the recent addition to our Rules & Regulations regarding e-Bikes, the **Board of Directors wanted to provide** some safety tips to those wishing to enjoy the use of electric bicycles at **Woodhaven Lakes** 

Rules & Regulations - Article II, Section 1, G.
Low-Speed Electric Bicycles (e-Bikes). The State of Illinois recognizes three classifications of low-speed electric bicycles. They

- "Class 2 low-speed electric bicycle" means a low-speed electric bicycle equipped with a motor that may be used exclusively
- when the rider is pedaling and that ceases to provide assistance when the bicycle reaches a speed of 28 miles per hour.

#### **CALL TO ORDER**

Dan Rossi, President, welcomed everyone to the Annual Meeting and called the meeting to order.

#### APPROVAL OF MINUTES

Dan Rossi asked for the approval of minutes from the 2022 Annual Meeting. Ernest Mitchell 16-79 & 80 made a motion to approve the minutes, Heather Hansen 12-48 seconded the motion. Motion passed unanimously.

#### TREASURER'S REPORT

Laura Packwood gave a brief overview of the Association's financial position in the Annual Report. Laura referenced the Independent Auditor's Report from WIFPLI on page 13. Laura indicated we did have an unqualified opinion which is favorable from the Audit. Fraud was initially found in January of 2022 and subsequent fraud was found while preparing for the audit. Laura referenced page 15 and read through these sheets to indicate where the fraud has been placed in the audit report. Laura referenced page 25 to explain foot note K, which explains what was done with the fraudulent funds. Our total assets for the period ending 2022 were \$34,277,315 and for the period ending 2021 were \$33,751,415. Total Liabilities were \$8,636,936 in 2022 and \$8,488,993 in 2021. On page 16, the consolidated statements of income and Association equity show a total revenue of \$12,145,816 in 2022 and \$11,520,114 in 2021. Operating expenses were \$9,977,396 in 2022 and \$9,118,954 in 2021. The year-end Association equity was \$25,640,379 in 2022 and \$25,262,422 in 2021. Currently, the Association is very healthy and very well balanced. On page 17, our net cash flow from operating activities was \$1,559,529 in 2022 and \$4,178,751 in 2021. The beginning balance for our cash and cash equivalents (restricted and unrestricted) was \$9,024,662 in 2022 and \$4,563,183 in 2021 and the ending balance was \$9,741,355 in 2022 and \$9,024,662 in 2021. Laura referenced page 26 to review supplementary information regarding future major repairs and replacements.

#### **EXECUTIVE DIRECTOR'S REPORT**

Jeff Hickey thanked everyone for attending the meeting. Jeff introduced the staff members who were at the meeting. Changes, adversity, and response is the focus of Jeff's report. Jeff referenced pages 11 and 12 of the report to view the organization structure. He highlighted the new position of General Manager of Maintenance Services. The goal is to prepare Woodhaven for the future and build a foundation for long-term employees that will be retiring.

Jeff shared accomplishments from the last year including the look of the Woodhaven News, addition of disc golf, pickleball courts, unacceptable material compound, air burner and firewood processor, upgrade to Well #2, and various shoreline improvements.

Jeff referenced the tornado that occurred on March 31, 2023. He complimented Woodhaven's response and the people responsible: Greg Dimmig, Rick Farringer, and all the other staff that responded to that event.

Jeff discussed the changes within the financial operations and discussed the audit report. He referenced page 13 and 14 to view the audit team response. The biggest change was the reclassification of reserves. There is more detail in footnote J. Jeff referenced footnote K regarding the fraudulent activity. Clifton Larson Allen added footnote L which repeats the information from pages 26-29. It shows the allocation of reserve dollars. The Association received a clean opinion. Jeff clarified that doesn't mean it is good or bad, just that it is accurate and reliable.

Jeff complimented the Board for the progress they have made with the challenges that have been presented to them. The goals and objectives are mutual between staff and the Board. He thanked them for the time and energy given to Woodhaven.

Woodhaven continues to excel and provide services and facilities at a very affordable level. Jeff thanked the Board, committee members, staff, and all owners.

#### STATE OF THE ASSOCIATION

Dan Rossi read the State of the Association letter in the Annual Report.

#### ACKNOWLEDGEMENTS

Dan Rossi asked that any committee members present at the meeting please stand when their committee is named to be recognized which included Section Representatives Committee, ESAC Board of Review, Public Safety Board of Review, Facilities Planning Committee, Finance Committee, Communications Committee, Deer Management Ad-Hoc Committee, Audit Committee, and Environmental Committee. Dan stated that they will be appointing 2 members to join the Environmental Committee as the two previous members have sold their property.

#### MEMBER BUSINESS FROM THE FLOOR

Marc Talavera, Section 3 Lots 84 & 85 - Marc asked if there have been any changes in process or controls as a result of the fraud to ensure this doesn't happen again. Jeff said that coinless systems have been implemented. This situation arose because internal controls were not followed. There has been a lot done to reinstate those internal controls and emphasized and added to them. Segregation of duties played a large part in the fraud. Laura added that additional checks and balances have been put into place and followed more closely. Marc then asked what is the ideal amount for reserves? Jeff said there is not a set standard in the industry. In the municipal governance, it is 1 years' worth of operating costs. In the private association industry, it is measured by the value of your assets. He references pages 26-28 of the annual report to explain the reserves. The goal of our organization is to stay above 30% funded.

*Kris Prangle, Section 24 Lot 69 –* She gave kudos to whoever came up with the chart on the bottom of page 25. Kris asked if we get to the point that we must do something with the deer, would that fall under the grounds category? Jeff said probably not because there is no physical asset that is involved with the deer management program. It would come out of the operating budget and will probably flow through resource management.

Sharon Kelley, Section 9 Lot 189 & 190 - Sharon asked the extent of the damage to the Lakeside Building and is there a project to get that repaired? Charlie said that engineers have come out to look at the extent of damage and repairs needed. This project will be discussed in the upcoming budget. Dan confirmed it will remain closed until work is done.

Liz Moran-Stelk, Section 23 Lot 166 (not an owner of record, guest) – Liz extended her appreciation for the Board and staff for everything they do to create a welcoming place to bring her kids to. She expressed her concern regarding a confederate flag that is flying on a neighboring lot and causes harm to others. She asked the Board to consider if this is ok in this community. Dan said he was not aware, but they will look into it. Chris added that this is a free speech issue, and the effect it has on other people. He said this will be discussed and can let her know where that conversation goes.

Kris Prangle, Section 24 Lot 69 - In an HOA, you can only fly the American flag. She asked how a residential area is different from a recreational area? Dan said he is in an HOA and that information is not accurate. Different flags just must be approved. Jeff clarified that the law was put into place because some HOAs were banning the American flag. It doesn't tell you what flags to fly, just that you can't ban flying the American flag.

*Frank Mucci, Section 14 Lot 2* – Frank said he has the highest faith in the Board knowing they will take care of the financials. Facilities Planning said the grounds always look great. If you have concerns, just bring them up, and most of the time those items are already on a list. He complimented the lifeguards for the work they do and the responsibilities they take. He referred to the article in the publication regarding the rescue. He commended the ice cream staff as well for their work.

#### **ADJOURNMENT**

Laurie Picha, Section 24 Lots 9, 10, & 11 made a motion to adjourn the Annual Meeting. Ernest Mitchell, Section 16 Lot 79 & 80 seconded. Motion passed unanimously. The meeting was adjourned.



# **New Package Policy**

As you may have already read in previous issues of the Woodhaven News, the Board has adopted an official policy regarding Owner packages delivered to the Association Office. The below policy is in effect as of December; please be sure to read through all the parameters before ordering a package to be delivered to the Association. Packages received by the Association that do not follow the policy will be returned to the carrier without notice. This Policy can also be found in the Policy Manual as 04-200-1223 Package Handling Policy.

- 1. Packages must be addressed to 509 Lamoille Rd., Sublette, IL 61367.
- 2. Packages must be addressed to an Owner of Record as shown on the deed, and the Section/Lot of the Owner must be listed in the address.
- 3. Packages weighing 60 pounds or less will be accepted. Any Packages received over 60 pounds will be rejected at time of receipt and returned to carrier, at no cost to the Association.
- 4. The Association will log the name of the person picking up packages. The Association is not responsible for the package(s) once they are logged out.
- 5. Owners are responsible for the removal of packages from the Association office area.
- 6. Packages are expected to be picked up within a week. Packages remaining 30 days after receipt will be returned to the carrier, at no cost to the Association.
- 7. Non-conformance to any part of this policy will result in rejection/return of the package(s) to the carrier without notice, and at no cost to the Association. Rejection/Return of packages to the carrier will be noted in the Association log.



Their mission statement is "to collect, review and analyze data related to Woodhaven's deer population and make recommendations to the Board of Directors based on this data for the purpose of maintaining a well-balanced and healthy deer herd at Woodhaven."

#### DEER MANAGEMENT AD-HOC COMMITTEE

#### PRIMARY OPTION

The primary option that was voted on and approved by the Deer Management Committee was to continue the process of obtaining a Deer Population Control Permit (DPCP). These permits are given to associations, municipalities, etc. The permit that is submitted will contain damage to vegetation, Property Owner feedback and evidence of increased deer numbers. If the permit is accepted, we would target 100 antlerless deer. All deer harvested will be tested for CWD and of the deer that test negative, they will be donated to food pantries to help feed families. The shooting would be done at stationary locations in isolated areas over bait using rifles with low energy ammunition at close range and would be done by trained and experienced USDA staff. This would occur at night in January and February and notification will be put out well in advance.

#### SUPPLEMENTAL OPTION

The supplemental option that was voted on and approved by the Deer Management Committee was to provide neighboring landowner/hunter with incentives to take more does. Local landowners are willing to harvest more deer if the meat is utilized and there is no financial burden on them for processing. The landowner would be responsible for prepping the deer for processing then taken to a site to be processed. This option is to help supplement the DPCP.

The primary and secondary options were approved by the Deer Management Committee to be reviewed by the Board of Directors. The Board of Directors will vote on the recommendations from the Deer Management Committee as an agenda item during a future board meeting.

Be on the lookout for September's *Woodhaven News* where we will have options for deer deterrents. It will have the do's and don'ts of deer deterrents.

In regard to the Illinois Department of Natural Resources Section 635.40 Feeding or baiting wildlife, It shall be illegal to make available food, salt, mineral blocks or other products for ingestion by wild deer or other wildlife in areas where wild deer are present.

Bird/squirrel feeders providing seed, grain, fruit, worms or suet for birds or squirrels should be elevated. We are recommending a minimum of 8 feet high in elevation so deer cannot reach the feeders.

#### DAILY CATCH LIMITS AND RULES - 2024

- Woodhaven Lake largemouth bass harvest up to 3 fish under 12 inches and "Catch & Release" on fish 12 inches and greater.
- Bass Lake largemouth bass harvest up to 3 fish under 12 inches and "Catch & Release" on fish 12 inches and greater.
- Pine, Sunset, Black Oak, Hidden & Bluegill lakes 1 largemouth bass/day, 14 inch minimum length limit.
- All Lakes 15 fish combined catch limit on bluegill and redear species.
- All lakes 15 fish limit on crappie
- All Lakes 4 fish limit on channel catfish.
- All lakes return grass carp to the lake
- All lakes No limit on common carp, bullhead, and green sunfish species.
- All lakes NO MINNOWS: using live minnows can introduce unwanted species/ organisms into our lakes.
- No harvesting of turtles. This is geared mainly towards snapping turtles in which populations have been declining in the State over the years due to overharvest.
- 11. 2 poles and line only in the water at a time for all the lakes on property. With this restriction, anglers would be allowed to have multiple poles but only 2 lines in the water at a given time.
- 12. No unattended fishing devices allowed at any time on any of the lakes. Unattended devices can cause mortality to fish and turtles that should be released if undersize as well as interfere with boaters using the lakes.
- 13. No trotline or jug fishing on any of the lakes. Given our fisheries are recreational, I believe these devices are damaging to our fisheries and interfere with boaters using the lakes.




#### Nature Nuggets: Let's take a closer look at local nature!

This month we'll focus on a summer tree species: Maples (Acer spp). wThere are thirteen species of maple native to North America and nearly 130 types of maple trees found around the world. All maples have certain similarities.

The most common species of native maples around Woodhaven Lakes are the Silver and Sugar Maples. Silver maples are fast growing and long-lived. They get their name from the silvery color on the bottom side of the leaves which makes them easy to identify. Silver maples have a weak growth structure that can lead to easy breakage during storms. The leaves are 5-7 inches wide and have five-lobes that are deeply clefted. They are light green on the upper surface and silvery on the underside with a fine-tooth leaf margin.



Sugar maples are economically important as they are the tree that produces maple syrup. Sugar maples grow well in soils that are in the middle, not too wet or too dry. They are tolerant of shade and do well in large yards or parks. Sugar maple leaves are 3-5 inches wide and have five-lobes. They have bright green upper surfaces and paler green lower surfaces without a fine-tooth leaf margin.



Maple trees are great habitats for all types of wildlife. They provide dense foliage, high refuges, and nutritious forage for squirrels, birds, and other small and medium sized animals. The spring flowers of maples are important for several species of pollinators.



Fun fact: Box Elder trees are in the maple family as well and a close relative to the Silver

Maple. Box elder bugs feed on the box elder tree as well as silver maples.


